 - In Rule (1) Article 2, the last sentence ("This decision should be approved by the Asian Committee for Future Accelerators (ACFA)") is removed from the original proposal to avoid any confusion of roles between ACFA and OC.
 - In Rule (1) Article 3, the word "next" in the second last line of first paragraph is replaced by "following" to clarify the meaning.
 - In Rule (2) Article 1, "d) Poster prize" is added.
 - In Rule (2) Article 2, "a medal and a certificate" is changed to "a medal or plaque, and a certificate."
 - There is a discussion about making medals. Due to difficulties associated with making medals such as medal design (both sides) and mold fabrication, it is decided that plaques can be replaced with medals
